



TERMS & CONDITIONS

1. *The Promoter*
 - 1.1 The promoter of this prize draw is: TEKA KUCHENTECHNIK UAE LLC. P.O. Box 35142, Dubai, UAE (“TEKA”)
2. *The Competition*

3. *How to Enter*
